




Unacceptable behaviour



In the last 12 months 9.5% of MFAT staff said they experienced harassment or bullying.

This compares to 12.1% in the Public Service overall.

Of the people at MFAT who experienced bullying or harassment, 42% have reported the behaviour.

Each person's score is calculated based on the questions they answered, and then these individual scores are combined to get a measure of overall engagement for the group.









* These questions were asked of those who either identified as being disabled, or chose *prefer not to answer* or *don't know* to that question and said *yes* to having either a neurodivergent or mental heath condition. This was **4.2%** of staff at your agency.

These results likely understimate the prevalence of disability in the workforce. A different method was used to measure disability in 2021, so results are not comparable between time periods.
