




Exploring your results

	Take time to understand your report. Consider your response rate to determine how representative your results are of the views of your colleagues.
	Most questions in this report have information about the proportion of colleagues responding positively, neutrally or negatively.
	Identify the areas where you are performing well. These will tend to be high results which are notably above any comparative results. Celebrate these results.
	Identify areas that need improvement. These will be the lower results, and/or those which are scoring notably below your comparators.








How is the index made?

Each person's score is calculated based on the questions they answered, and then these individual scores are combined to get a measure of overall engagement for the group.


Satisfaction with pay \$




Employee Demographics 2025








Gender

Languages Spoken




Self-reported Mental Health
