\* These questions were asked of those who either identified as being disabled, or chose *prefer not to answer* or *don't know* to that question and said yes to having either a neurodivergent or mental health condition. This was **8.4%** of staff at your agency.

These results likely underestimate the prevalence of disability in the workforce. A different method was used to measure disability in 2021, so results are not comparable between time periods.
