#### Executive Summary

- 1 The State Services Commissioner intends to appoint Mr Chris Seed as Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade.
- 2 The Minister of Foreign Affairs and Trade, Rt Hon Winston Peters, has been briefed and is supportive of the proposal to appoint Mr Seed to the role.
- 3 In accordance with section 38 of the State Sector Act 1988, the State Services Commissioner is required to consult with you and the Prime Minister before finalising the terms and conditions of employment for Mr Seed.
- 4 Your office will receive a letter on Monday 10 December the relevant terms and conditions agreed with Mr Seed to be signed by you and the Prime Minister ahead of APH.

# Appointment: Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade

- 1 The State Services Commissioner (the Commissioner) has forwarded to me, as the Minister of State Services, a recommendation for the appointment of Mr Christopher John Seed to the position of Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade, under section 35 of the State Sector Act 1988 (the Act).
- 2 I now submit the Commissioner's recommendation, attached under this coversheet, to the Cabinet Appointments and Honours Committee for consideration and referral to the Governor-General in Council, via Cabinet.
- 3 The Responsible Minister and I have been consulted by the Commissioner about this appointment.
- 4 The Commissioner will consult the Prime Minister and I before finalising conditions of employment for Mr Seed, including his term of appointment, as required under section 38 of the Act.

#### Recommendations

- 5 I recommend that Cabinet:
  - accept the recommendation of the Commissioner to appoint Mr Christopher John SEED to the position of Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade;
  - 2 **refer** the recommendation and the attached curriculum vitae to the Governor-General in Council;
  - 3 note that the Commissioner is consulting with the Prime Minister and the Minister of State Services before finalising terms and conditions of employment with Mr Seed;
  - 4 **note** that under the State Sector Act 1988, the Commissioner is required to publicly announce appointments; and
    - **note** that, subject to the Governor-General's acceptance of the Commissioner's recommendation, the Commissioner intends to:
      - 5.1 publicly announce the appointment of Mr Seed; and

# Appointment: Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade

#### Proposal

- 1 I recommend that Mr Christopher John Seed be appointed to the position of Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade for a term of five years from 1 February 2019 to 31 January 2024.
- 2 Mr Seed is currently the New Zealand High Commissioner to Australia, a role he has held since November 2013. He has previously served as the High Commissioner in Port Moresby. Within the Ministry of Foreign Affairs and Trade (the Ministry), he has held the role of Deputy Secretary of Australia, Pacific, Middle East and Africa and Europe Group, where he led a large extended team of over 400 staff across 13 international locations.
- 3 Mr Seed is an experienced diplomat and a committed and dedicated public servant, with a broad career background with the Ministry. His values and beliefs align strongly with the foreign service goals of the sector, Government and the Ministry.
- 4 I consider that Mr Seed has the necessary skills and experience to successfully lead the Ministry. A copy of his summarised curriculum vitae is attached.
- 5 I propose that you forward my recommendation to Cabinet for referral to the Governor-General in Council. A warrant for execution by the Governor-General is attached.

#### Background

- 6 The position of Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade (Secretary of Foreign Affairs and Trade) will become vacant on 1 February 2019 when Mr Brook Barrington will transfer to the position of Chief Executive, Department of the Prime Minister and Cabinet.
- 7 The Ministry acts in the world to make New Zealanders safer and more prosperous. It contributes directly to the prosperity and security of all New Zealanders, delivers New Zealand's international development co-operation programme and advances the interests and reputation of New Zealand overseas.
- 8 The Secretary of Foreign Affairs and Trade leads a department of approximately 1,500 staff which includes a network of 58 posts in 51 countries, engaging with international agencies, non-governmental organisations, businesses and the wider international public. In 2018/19, Vote Foreign Affairs and Trade's total budget was \$1.3 billion.
- 9 The position description was considered by the Cabinet Appointments and Honours Committee on 4 July 2018 and confirmed as the basis for the recruitment to the role.

#### Requirements of the Position

10 The Secretary of Foreign Affairs and Trade will be responsible for delivering on the Government's foreign policy, international trade policy, international development policy

and international climate change policy objectives as well as contributing to New Zealand's broader security, economic and environmental objectives, through:

- providing high quality advice on foreign policy and advancing the Government's international security, economic development and environmental interests;
- conducting relations with other countries and international organisations, and in that context advocating for and representing New Zealand's view;
- negotiating agreements on behalf of New Zealand; and
- delivering protocol and consular services and contributing to humanitarian assistance and disaster responses.

#### Selection Process

- 11 I have undertaken a comprehensive search for the next Secretary of Foreign Affairs and Trade, including the engagement of external search and assessment consultants.
- 12 The vacancy was advertised online and in newspapers from 13 July 2018. Applications closed on 8 August 2018.
- 13 <sup>9(2)(a) privacy</sup>candidates applied for the position.<sup>9(2)(a) privacy</sup>applicants were shortlisted for panel interview.
- 14 The shortlisted candidates were interviewed on Thursday, 11 October 2018 by a panel comprising of:
  - Mr Peter Hughes, State Services Commissioner (Chair);
  - myself, Deputy State Services Commissioner;
  - Dame Fran Wilde, DNZM, QSO, JP; and
  - Mr Simon Murdoch, CNZM.

#### Recommended Appointee

- 15 I recommend the appointment of Mr Chris Seed to the position of Secretary of Foreign Affairs and Trade for a five year term.
- 16 Mr Seed is an experienced and well-respected senior foreign policy leader. He has deep institutional knowledge and experience of the Ministry's role domestically and internationally, and he is recognised as a highly capable tactician, with excellent geopolitical analysis and judgment.
- 17 In both his international postings and senior leadership roles at the Ministry, Mr Seed has led the management, mitigation and contextualising of a number of geo-political issues, to represent and protect New Zealand's interests overseas. He is conscious of the challenges inherent in connecting across a large organisation and is effective at motivating a disparate group onshore and offshore to deliver on key priorities.
  - As High Commissioner to Australia, he has proven to be adept at managing New Zealand's important and complex diplomatic relationship with Australia, able to effectively navigate the political interface, balancing competing interests and optimising opportunities.
- 19 Mr Seed has led a number of significant initiatives to further New Zealand's Foreign Affairs and Trade agenda. Some key successes include improving opportunities for New Zealand industry in the Australian market and working to raise New Zealand's profile in the Pacific region.

#### IN-CONFIDENCE

- 20 Alongside his diplomatic career, Mr Seed spent some time working as the Deputy Secretary of Defence, Policy and Planning at the Ministry of Defence.
- 21 Mr Seed holds a Bachelor of Arts (First Class Honours) and a Master of Arts in History both from Massey University.
- 22 Mr Seed's referees all state that he is well-qualified for the role and would be a good fit for the Ministry. He is down-to-earth and genuine. He has excellent interpersonal skills that people respond to, he earns respect and trust and staff are always happy to take their lead from him. He is an effective communicator and is articulate. Mr Seed's referees note his unflappable demeanour when under pressure. Referees acknowledge that the role of High Commissioner to Australia is a challenging post, but that Mr Seed was calm and professional when dealing with complex and demanding priorities and when under scrutiny.
- 23 Mr Seed's referees state that he is sharply focused on the issues that matter most not only the Ministry's interests, but the wider interests of New Zealand. His decision-making is thoughtful, considered and well-executed to achieve high quality outcomes. He is tactical in his approach, able to read situations and people well, recognise risks and opportunities, and exercise very good judgment. People value his insight and navigation on issues.
- 24 In summary, I am of the view that Mr Chris Seed meets the requirements outlined in the attached position description.

#### Conditions of Employment

- 25 I have consulted the Rt Hon Winston Peters, Minister of Foreign Affairs on the proposed appointment.
- 26 In accordance with section 38 of the State Sector Act 1988 (the Act), I will consult with you and the Prime Minister before finalising the terms and conditions of employment for Mr Seed, including a proposed five year term of appointment.
- 27 The Secretary of Foreign Affairs and Trade must be able to obtain and maintain a Top Secret Special security clearance.

#### Publicity

- 28 Subject to the Governor-General's acceptance of my recommendation above, I intend to publicly announce the appointment of Mr Seed on Tuesday 18 December 2018. This will meet my obligation under the Act to publicly notify appointments.
- 29 It is also my intention to publicly release associated documents, including this paper, on the State Services Commission's website, as is our standard practice for Chief Executive appointment recommendations. The documents will have any necessary redactions in accordance with the Official Information Act 1982. You will be consulted on the communications plan and material to be released.

#### Recommendations

- 30 I recommend that you:
  - 1 forward my recommendation to appoint Mr Christopher John SEED to the position of Secretary of Foreign Affairs and Trade and Chief Executive, Ministry of Foreign Affairs and Trade, to the Cabinet Appointments and Honours Committee for referral to the Governor-General in Council;
  - 2 note that a warrant for appointment is attached for execution by the Governor-General in due course;

- note that I will consult with the Prime Minister and you, as Minister of State Services, 3 before finalising terms and conditions of employment for Mr Chris Seed, including his term of appointment;

- leading an integrated approach in conjunction with the NZ Inc. agencies and business partners to strengthen New Zealand's international political, security, trade, economic, and environment relationships;
  - vengaging effectively with the commercial sector, including major exporters;
  - providing diplomatic and consular services and advice;
  - providing effective International Development Assistance programmes in line with New Zealand's national interests;
- administering 30 pieces of legislation, with the International Crimes and International Criminal Court Act 2000 and the Terrorism Suppression Act 2002 jointly administered with the Ministry of Justice;
- ensuring that the Ministry's resources are effectively managed including through prudent fiscal management;
- establishing and maintaining effective relationships and networks with business, iwi and interest groups including in the environment sector; and
- providing leadership, effective management and development of the Ministry, so that it can contribute to the achievement of agreed outcomes now and in the future.
