Executive Summary

1. The Public Service Commissioner has advised that he intends to extend the appointment of Deputy Public Service Commissioner, Ms Rebecca Kitteridge CVO, to act as Secretary of the Department of the Prime Minister and Cabinet and Chief Executive, Department of the Prime Minister and Cabinet, for a further term from 31 January 2024 until a substantive appointment

is made (expected to be made by 30 June 2024 at the latest), pursuant to Schedule 7 clause 9(2) of the Public Service Act 2020.

- 2. Consequently, the Public Service Commissioner is also asking the Prime Minister to recommend the Governor-General approve an extension to Ms Gaye Searancke's appointment as Deputy Public Service Commissioner, for a further term from 31 January 2024 to 30 June 2024, pursuant to Schedule 4 clause 2(1) of the Public Service Act 2020. Ms Searancke has held this position since 27 March 2023, while Ms Kitteridge has been Secretary of the DPMC.
- 3. Ms Searancke has advised that she would resign from her acting role if a substantive appointment to the DPMC role is made before 30 June 2024 requiring Ms Kitteridge to return to her substantive role as Deputy Public Service Commissioner.

Purpose

This aide-memoire provides you with information and talking points to support you in taking the Prime Minister's recommendations to the Governor-General to approve the appointment of Ms Gaye Searancke as the Deputy Public Service Commissioner for a further term from 31 January 2024 to 30

June 2024.

Proposal

The Prime Minister is recommending that her Excellency the Governor-General approves the further acting appointments of Ms Gaye Marie Searancke as Deputy Public Service Commissioner from 31 January 2024 to 30 June 2024.

Background

- The Public Service Act 2020 (the Act) provides for two statutory Deputy Public Service Commissioner roles appointed by the Governor-General on the recommendation of the Prime Minister.
- Ms Heather Baggott holds one office and Ms Kitteridge commenced as the other Deputy Public Service Commissioner on 1 March 2023.
- Ms Kitteridge was appointed to act as Secretary of the DPMC from 8 March 2023 to 30 January 2024, to enable the substantive role holder, Mr Brook Barrington, to take a leave of absence to be with his family.
- To fill the vacancy in the Deputy Public Service Commissioner role created by Ms Kitteridge
 acting as Secretary of the DPMC, the Governor-General's approval to appoint Ms Gaye
 Searancke as Deputy Public Service Commissioner was also sought and secured. Ms
 Searancke commenced in that role on 27 March 2023 with a term end of 30 January 2024.

Key points

Extending the Deputy Public Service Commissioner arrangements

- Mr Barrington recently advised the Public Service Commissioner of his resignation from the role of Secretary of the DPMC, creating a vacancy in the position.
- The Public Service Commissioner intends to appoint Ms Kitteridge to continue to act in this position under Schedule 7 clause 9(2) of the Act.
- The Governor-General's agreement is needed to extend Ms Searancke and enable her to exercise the statutory powers of the Deputy Public Service Commissioner position.
- It is therefore the Prime Minister's recommendation to the Governor-General that Ms Searancke's role as Deputy Public Service Commissioner be extended from 31 January 2024 to 30 June 2024, pursuant to Schedule 4 clause 2(1) of the Act.

• Ms Searancke has advised that she would resign from her acting role if a substantive appointment to the DPMC role is made before 30 June 2024 requiring Ms Kitteridge to return to her substantive role as Deputy Public Service Commissioner.

Warrant

In the past, the Minister for the Public Service has typically managed the appointment of a
Deputy Public Service Commissioner on behalf of the Prime Minister. This includes the
presentation of the warrant for the appointee to the Governor-General. The Prime Minister
also provides an accompanying letter outlining his recommendation and requesting the
Governor-General's approval.

Recommended appointee, Deputy Public Service Commissioner

- Deputy Public Service Commissioners bring knowledge, capability and experience of Public Service management and leadership and work as a team with the Commissioner to ensure the Public Service delivers for New Zealanders and to the Government's priorities.
- The Prime Minister considers Ms Searancke continues to meet these requirements and is suitable to have her term as Deputy Public Service Commissioner extended to 30 June 2024, bringing her total time in role to 15 months.
- Ms Searancke has a Bachelor of Laws from Otago University. Her current substantive position
 is Secretary for Land Information and Chief Executive, Land Information New Zealand, a
 position she has held since 2019. Prior to that, she held a wide range of senior Public Service
 roles.
- Ms Searancke is an experienced and successful leader and a respected member of the Public Service Leadership Team. She has demonstrated her capability in undertaking the functions of Deputy Public Service Commissioner and her skills complement those of Ms Heather Baggott, the other Deputy Public Service Commissioner.
- By continuing in the role to June 2024, Ms Searancke will provide continuity in the leadership of the Public Service and support for the incoming Public Service Commissioner following the retirement of the current Public Service Commissioner on 29 February 2024.
- The Prime Minister considers that Ms Searancke meets the requirements for the role, and recommends her acting term be extended.

Extending Deputy Public Service Commissioner arrangements

Proposal

- 1 It is proposed that Cabinet notes:
 - 1.1. The Public Service Commissioner's intention to extend the appointment of the Deputy Public Service Commissioner, Ms Rebecca Lucy Kitteridge CVO to act as Secretary of the Department of the Prime Minister and Cabinet and Chief Executive, Department of the Prime Minister and Cabinet (DPMC), for a further term from 31 January 2024 until a substantive appointment is made (expected to be made by 30 June 2024 at the latest), pursuant to Schedule 7 clause 9(2) of the Public Service Act 2020.
 - 1.2. The Prime Minister's recommendation to the Governor-General to consequently extend the appointment of Ms Gaye Marie Searancke as acting Deputy Public Service Commissioner for a further term from 31 January 2024 to 30 June 2024, pursuant to Schedule 4 clause 2(1) of the Public Service Act 2020.

Background to current arrangements

- The Public Service Act 2020 (the Act) provides for two statutory Deputy Public Service Commissioner roles. Under section 47(1) of the Act, Deputy Public Service Commissioners are appointed by the Governor-General on the recommendation of the Prime Minister.
- 3 Ms Heather Baggott holds office as one Deputy Public Service Commissioner. Ms Kitteridge has held the other since 1 March 2023.
- 4 Ms Kitteridge was appointed to act as Secretary of the DPMC from 8 March 2023 to 30 January 2024, to enable the substantive role holder, Mr Brook Barrington, to take a leave of absence to be with his family [CAB-23-MIN-0062].
- To fill the vacancy in the Deputy Public Service Commissioner role created by Ms Kitteridge acting as Secretary of the DPMC, the Governor-General's approval to appoint Ms Gaye Searancke as Deputy Public Service Commissioner was also sought and secured. Ms Searancke commenced in that role on 27 March 2023 with a term end of 30 January 2024.

Extending the Deputy Public Service Commissioner arrangements

6 Mr Barrington recently advised the Public Service Commissioner of his resignation from the role of Secretary of the DPMC, creating a vacancy in the position.

- 7 The Public Service Commissioner intends to appoint Ms Kitteridge to continue to act in this position under Schedule 7 clause 9(2) of the Act.
- The Governor-General's agreement is needed to extend Ms Searancke and enable her to exercise the statutory powers of the Deputy Public Service Commissioner position. Recommended appointee

- The criteria for appointing Deputy Public Service Commissioners are not prescribed in legislation. In the absence of that, considerations for this appointment included whether the candidates were honest and trustworthy, and had the necessary experience, qualifications and characteristics to perform the role which includes exercising all the functions, powers and duties of the Public Service Commissioner.
- 10 Deputy Public Service Commissioners bring knowledge, capability and experience of Public Service management and leadership and work as a team with the Commissioner to ensure the Public Service delivers for New Zealanders and to the Government's priorities.
- 11 The Prime Minister considers Ms Searancke continues to meet these requirements and is suitable to have her term as Deputy Public Service Commissioner extended to 30 June 2024, bringing her total time in role to 15 months.
- Ms Searancke has a Bachelor of Laws from Otago University. Her current substantive position is Secretary for Land Information and Chief Executive, Land Information New Zealand, a position she has held since 2019. Prior to that, she held a wide range of senior Public Service roles.
- 13 Ms Searancke is an experienced and successful leader and a respected member of the Public Service Leadership Team. She has demonstrated her capability in undertaking the functions of Deputy Public Service Commissioner and her skills complement those of Ms Heather Baggott, the other Deputy Public Service Commissioner. By continuing in the role to June 2024, Ms Searancke will provide continuity in the leadership of the Public Service and support for the incoming Public Service Commissioner following the retirement of the current Public Service Commissioner on 29 February 2024.
- 14 Ms Searancke's summarised CV is attached.

Conditions of Appointment

- The remuneration of the Deputy Public Service Commissioner is determined by the Remuneration Authority. The other Conditions of Appointment, including leave and other entitlements, are agreed between the appointee and the Public Service Commissioner.
- The Deputy Public Service Commissioner must be able to obtain and maintain a Top Secret Special security clearance. Ms Searancke has 9(2)(a) privacy security clearance.

Publicity

The Public Service Commissioner will inform the Public Service Leadership Team. As Deputy Public Service Commissioner appointments are made by the Governor-General on the recommendation of the Prime Minister, the Prime Minister or Minister for the Public Service may choose to make a media announcement. No media statement was issued when the arrangements commenced.

Recommendations

- 18 The Prime Minister and the Minister for the Public Service recommend that Cabinet:
 - note the Public Service Commissioner's intention to extend the appointment of Ms Rebecca Lucy Kitteridge CVO to act as Secretary of the Department of the Prime Minister and Cabinet and Chief Executive, Department of the Prime Minister and Cabinet for a further term from 31 January 2024 to 30 June 2024 (or an earlier date if a permanent appointment to the role is made), pursuant to Schedule 7 clause 9(2) of the Public Service Act 2020.
 - note the Prime Minister's recommendation to the Governor-General to consequently extend the appointment of Ms Gaye Marie Searancke as acting Deputy Public Service Commissioner, for a further term from 31 January 2024 to 30 June 2024, pursuant to Schedule 4 clause 2(1) of the Public Service Act 2020;
 - 3 9(2)(a) privacy
 - 4 note the remuneration for the Deputy Public Service Commissioner is determined by the Remuneration Authority and other Conditions of Appointment, including leave management, are agreed between the appointee and the Public Service Commissioner;
 - note that the Public Service Commission will inform the Public Service Leadership Team. As Deputy Public Service Commissioner appointments are made by the Governor-General on the recommendation of the Prime Minister, the Prime Minister or Minister for the Public Service may choose to make a media announcement;

Under section 47(1) of the Public Service Act 2020 ("the Act") two statutory Deputy Public Service Commissioners must be appointed by the Governor-General on the recommendation of the Prime Minister. Ms Heather Baggott holds office as one Deputy Public Service Commissioner. Ms Rebecca Kitteridge has held the other since 1 March 2023.

On 6 March 2023 Ms Kitteridge was appointed to act as Secretary of the Department of the Prime Minister and Chief Executive, Department of the Prime Minister and Cabinet for a period from 8 March 2023 to 30 January 2024 while Mr Brook Barrington, the current Secretary and Chief Executive, took an extended leave of absence.

Under Schedule 4 clause 2(1) of the Act the Governor-General may appoint an Acting Deputy Public Service Commissioner on the recommendation of the Prime Minister. To fill the Deputy Public Service Commissioner role held by Ms Kitteridge, in March 2023 your approval was sought and secured to Ms Gaye Searancke being appointed as Deputy Public Service Commissioner. Ms Searancke has held this role from 27 March 2023 to date.

Mr Barrington has recently advised the Public Service Commissioner of his resignation from the role of Secretary of the DPMC, creating a vacancy in the position. The Public Service Commissioner has advised that he intends to appoint Ms Kitteridge to act as Secretary for the DPMC for a further term until 30 June 2024, under Schedule 7 clause 9(2) of the Act.

Recommendation to extend the appointment of Deputy Public Service Commissioner

I recommend that you appoint Ms Gaye Searancke to continue to act as Deputy Public Service Commissioner, from 31 January 2024 to 30 June 2024, pursuant to Schedule 4 clause 2(1) of the Act, while Ms Kitteridge continues to act as the Secretary of the DPMC. Ms Searancke will step down from her role as Deputy Public Service Commissioner if Ms Kitteridge returns to her substantive position prior to 30 June 2024.

Ms Searancke is an experienced and successful leader, having undertaken a wide range of senior roles in the Public Service, including four years as the Secretary for Land Information and Chief Executive, Land Information New Zealand. She has demonstrated her capability in undertaking the functions of Deputy Public Service Commissioner and her skills complement those of Ms Baggott. By continuing in the role to June 2024, Ms Searancke will provide continuity in the leadership of the Public Service and support for the incoming Public Service Commissioner, following the retirement of the current Public Service Commissioner on 29 February 2024. Her summarised curriculum vitae is attached.
