## Official Information Request Our Ref: OIA 2024-0063

I refer to your official information request received on 12 March 2024 where you asked:

"Under the OIA, will you please confirm if NZ Inc.'s "Other Public Entities" are also subject to the Public Service Act 2020."

You subsequently clarified your request on 22 March 2024 where you asked:

- "1. Is the NZ Medical Council subject to the Public Service Act 2020?
- 2. Is the NZ Medical Council considered as part of the Public Sector or the NFP Sector? Or both.
- 3. Is the NZ Dental Council subject to the Public Service Act 2020?
- 4. Is the NZ Dental Council considered as part of the Public Sector or the NFP Sector? Or both.
- 5. As both Councils are NFP charity commissions, then if one or both are not subject to the Public Service Act 2020, are they instead subject to the Defence Act?"

## **Our response**

Both the Medical Council of New Zealand and the Dental Council of New Zealand are authorities under the Health Practitioners Competence Assurance Act 2003, and are governed by the provisions of that Act. They are part of the public sector (as entities associated with a ministerial portfolio) and the not-for-profit sector but are not part of the State Services or Public Service, and are therefore not subject to the provisions of the Public Service Act 2020.

## Information not held
