Thank you for your request for information, which we received on 28 September 2018, about the development of the Open Government Partnership National Action Plan 2018-20. You asked for the following information:

For each of the 12 commitments in the action plan, whether it was proposed by a member of the public during the consultation process, or by a public servant or government agency (and if so, which).

All the commitments respond to an idea or multiple ideas offered by members of the public during the ideas generation phase at the start of the consultation to develop the third National Action Plan. This includes ideas based on recommendations from the Open Government Partnership's (OGP) Independent Reporting Mechanism (IRM).

The 12 commitments were developed by agencies in response to 449 ideas offered. Most of the commitments reflect a specific idea offered by one or many people, for example civics education for young people, while other commitments respond to multiple, related ideas or underlying problems, for example on the regulatory regime and administrative practice for official information.

Following advice from OGP International, public servants were encouraged to submit any ideas during the ideas generation phase in April/May 2018. This ensured greater transparency for all ideas being proposed and allowed others to comment on all ideas. It also allowed public servants to offer ideas that reflect their personal views about opportunities to improve open government.

The spreadsheet, which you can find at www.ogp.org.nz/ogp-nap3-ideas-to-action-sept2018, demonstrates the linkages between ideas submitted and the themes and commitments in the draft plan.

Attached is a copy of that spreadsheet, sorted so you can see where the majority of the ideas contributed to the commitments. There is not a perfect match for some ideas that contributed to more than one theme and/or commitment.

I have set out more details below about how the public's ideas contributed to the commitments, in response to your second question.

All advice on the final selection of commitments. I'm interested in learning what criteria were used, whether a commitment being already underway was considered, any specific ranking or assessment of possible commitments, and what ultimately led to these particular commitments being chosen.

While there were some base criteria for the final selection of commitments (see below), as stated in answer to your first question, the Plan is the culmination of a process rather than the result of the application of a set of criteria. The 12 commitments were derived through a theming and synthesising process from the ideas generated by the engagement process. They may reflect an actual idea that was submitted and/or the subject matter of a number of ideas and/or a problem to which a number of ideas related.

Throughout the process agencies were tested and challenged to stretch both their ambition and the extent to which they will engage civil society in the implementation of commitments.

The criteria

The criteria applied to the development of commitments was derived from the OGP expectations and notified at the commencement of the process. See:

The process to select the commitments

The Expert Advisory Panel (EAP) provided advice on the process for and development of the draft National Action Plan 2018-20, and was involved at each stage of development of the commitments. See details about the EAP members involved here: www.ogp.org.nz/nap3-expert-advisory-panel-sept2018.

In summary the process to arrive at the final 12 commitments was, as follows:

Engagement and ideas generation - April/May 2018

 We invited the public, including public servants, to provide ideas for the Plan online and at six workshops. All 449 ideas were posted on-line for other contributors to expand, rate or comment on.

Theming and Synthesis – June/July 2018

All 449 ideas were sorted into groups of like ideas for consideration at a meeting of officials and the Expert Advisory Panel (EAP) on 5 June. Seven themes were identified (listed in relative priority order by the meeting attendees). The themes and the ideas linked to them can be viewed on the OGPNZ website here: www.ogp.org.nz/new-zealands-plan/third-national-action-plan-2018-2020.
 At that meeting, some ideas were confirmed as out-of-scope for the open government programme and these have been referred on to the most relevant government agency.

- The OGP team at the State Services Commission contacted 17 agencies that were in a position to lead investigation of particular themes or sub-themes and asked them to identify possible initiatives to respond to the themes and related ideas. Initial discussion between the SSC officials and agencies tested and stretched the proposals for consideration at the synthesis workshop.
- The then Associate Minister for State Services (Open Government) advised her ministerial colleagues of the themes, highlighting the likely responsible portfolios, and seeking support and encouragement. Officials were also asked to ensure their Ministers were briefed if they were proposing initiatives to be included in the plan.
- At a synthesis workshop on 2 July, the EAP, representatives from the public workshops and officials discussed possible initiatives for all seven themes that had potential to become Plan commitments. The three priority themes were identified as well as the important overarching aspirations about diversity and inclusion. Preferred initiatives were also indicated.
- Some potential commitments were not progressed beyond this point because they were existing work programmes (e.g. protected disclosure and registers of beneficial ownership of companies and trusts) and did not have any particular aspects of additional work or stretch, in response to the ideas collected, that merited inclusion in the Plan. (See paragraph 18 of the draft Plan).
- The commitments all build directly or indirectly on existing agency and cross-agency work programmes aimed at improving open government. When agencies were approached to respond to the themes identified on 5 June we told them that proposed commitments needed to demonstrate a sufficient level of additional work or "stretch" for the government agency tasked with delivery. The level of 'stretch' was particularly important for any initiative that may have been planned, or was underway or was an expansion of a current programme. The level of stretch was tested and agencies pushed by the EAP (and Workshop attendees) as the Plan was developed.
- Two of the final commitments (Commitment 4 and 5) not only respond to ideas raised during the ideas generation phase but also follow on directly from commitments in the National Action Plan 2016-18. Commitment 4 relates to the 2016-18 commitment about improving access to legislation; this has been identified by the independent IRM researcher as potentially transformational and has starred status. The IRM researcher recommended that both these commitments be pursued further, see www.opengovpartnership.org/New-Zealand_MidTerm_2016-2018.pdf. Support for these recommendations was reiterated by Wellington workshop participants.

Developing the detail of the commitments – July/August 2018

- Officials from the lead agencies were tasked with testing potential commitments with Ministers and developing the detailed description of the commitments.
- On 11 July, officials presented proposed commitments at a workshop with the EAP. These commitments were further refined as a result of EAP's feedback to become the 12 commitments in the Draft Plan.

Ministerial confirmation of the draft Plan – August/September 2018
