## Official Information Request Our Ref: PSCR 2025-0164

I refer to your official information request received on 17 February 2025 where you asked:

*"I request under the Official Information Act:* 

Any advice, briefings, correspondence or other documents prepared by the Commission relating specifically to the process(es) for the recruitment, appointment, removal or replacement of appointed members of the Electricity Authority and/or the Energy Efficiency and Conservation Authority, between 1 November 2024 and 14 February.

I am not requesting general briefings about appointment/removal processes for Crown entities that are intended for a generic audience. I am not requesting names or identifying details of any individuals that may be referenced in any such documents and I am happy for these to be withheld".

## **Background information**

Te Kawa Mataaho Public Service Commission (the Commission) is not responsible for the recruitment, appointment, removal or replacement of appointed members of Crown entity boards. Usually, the relevant monitoring department of a Crown entity provides advice and support during the appointment and induction process for board members.

Ministers are generally responsible for board appointments, either directly or through recommendations to the Governor-General, and the removal from office before the end of a board member's term is an option available to Ministers. Generally, the person with authority to appoint a board member also has the power to remove or suspend a person from office. Unless there are specific statutory or governance provisions to the contrary, each board member holds office at the pleasure of the person (a Minister or the Governor-General as the case may be) who appointed them.
