- Copies of any reports, briefings, or plans produced by the taskforce, including information related to cost savings, structural changes, and health priorities.
- Copies of any communications regarding the potential inclusion of legislative changes to the Pae Ora (Healthy Futures) Act 2022, and the possible impact on iwi Māori partnership boards.
- Copies of any documents related to the possible incorporation of the taskforce's proposals into the upcoming Budget.
- Copies of any documents or internal discussions regarding Hamiora Bowkett's role in the taskforce.

Information being released

On 29 January 2025 the Minister of Health instructed the Public Service Commissioner to establish a Unit within Te Kawa Mataaho Public Service Commission (the Commission) to support the Minister of Health's focus on driving the delivery of the Government's key priorities for Health NZ.

The Unit is also providing independent assurance to ensure the programme of work being progressed by Health NZ to deliver the health targets and priorities is supported by clear and effective plans and accountability arrangements.

The Unit is on a time limited basis to support the development of advice to enable the Minister of Health to drive accountability and performance in Health New Zealand. The Unit's initial work will

be finalised around early to mid-March 2025. The ongoing role and composition of the Unit beyond this period is still being worked through, however the work of the unit is expected to be completed by May 2025.

Health Sprint team

- A Sprint Team is being established this week within the Public Service Commission, led by Hamiora Bowkett. The Commission and DPMC will be supporting this team to direct resources and support the delivery of the team's work to support the Minister.
- The Sprint Team will provide the Minister with an independent perspective and advice, supported by Central Agencies, to help the Minister in driving change and delivery within Health NZ and the Ministry of Health. This includes ensuring the Minister is supported to use his levers and interventions.
- The immediate focus of the team over the next five weeks is on ensuring there is a clear plan against the critical areas to lift Health New Zealand's delivery and performance: Access to GPs and medicines; ED wait times; financial management; and capital programme delivery. This work will be focused on identifying critical levers and incentives to drive progress against to lift Health NZ's performance. This work will also consider the Ministry of Health's role to drive delivery in these areas.
- The Minister has a strong focus on getting assurance on Health New Zealand's financial
 management, particularly in relation to getting confidence over ensuring funding is going
 to where it needs to, and capital programme delivery. Both will be critical priorities for the
 Sprint Team to focus on as part of the first stage of work. The team and Central Agencies
 will need to draw on expertise in these areas to provide the Minister with confidence on
 the current state of play and actions required to address identified delivery and
 performance issues.
