Meeting with Open Government Partnership Expert Advisory Panel (EAP)

Purpose of Report

- 1. You are meeting with the OGP EAP. EAP is an advisory group for Te Kawa Mataaho Public Service Commission as part of the OGP process. It is made up of civil society representatives from diverse backgrounds. (See attached profiles)
- 2. This is the second time you will meet this EAP, having previously met with them on 24 July 2020.

Background

- 3. The EAP works with Te Kawa Mataaho and officials from agencies to develop and oversee the implementation of National Action Plans (NAPs). Of the six members, two (Suzanne Snively and Rachel Roberts) participated in the development of the current NAP.
- 4. EAP has indicated that they are in support of the letter you recently received from ten civil society organisations about the process for developing NAP4. The letter identified three reasons for making change to the current approach:
 - the plan is being developed without a budget for the commitments;
 - the process does not involve co-creation, it is a traditional consultation with insufficient time for substantive engagement;
 - the work to co-create the action plan is insufficiently resourced to achieve high quality public participation.
- 5. The civil society agencies asked that the plan be delayed from this year into next year in order to provide additional time to undertake collective development of the commitments.
- 6. You replied to the letter on 27 April 2021, agreeing that Te Kawa Mataaho will open a conversation with the OGP Secretariat to explore extending the submission date for NAP4 to 30 June 2022.
- 7. On 22 April, 2021, at the OGP EAP & Officials Quarterly Meeting, the Public Service Commissioner, Mr Peter Hughes, provided EAP with an outline of your response to the ten civil society organisations and discussed your plans for a programme of reform and development in relation to active citizenship, citizen voice in decision-making, and transparency and accountability.

Talking Points

EAP may raise with you:

- Budget for NAP commitments and better use of budget cycles in OGP processes
- Amplifying wider public awareness of OGP and open government initiatives
- That they were not aware of the civil society organisations letter to you and that while they support the overall thrust of the letter, they prefer not to extend NAP4 development for a further 12 months
- Their desire for you, as Minister for the Public Service, to be more involved in open government dialogue with New Zealanders

Your reply to the ten civil society organisations:

In your reply, sent on 27 April, you:

 supported the NAP4 timeframe extension request and have asked Te Kawa Mataaho to work with OGP to shift New Zealand into the 2022 cohort

- confirmed that budget for Commitments sits with agencies and is their responsibility
- outlined a program of work to commence around active citizenship and transparency

OGP is one tool and you are looking to push further:

- You support the possibility of a four-year National Action Plan as one means to address concerns around Commitments aligning better with budget cycles
- While extending the submission date for NAP4 to August 2022 makes sense, your plan for a
 programme of reform and development in relation to active citizenship, citizen voice in decisionmaking, and transparency and accountability needs to move quickly and cannot wait for the start of
 NAP4

As part of this this work progressing quickly, you:

- Have asked the Public Service Commissioner to advance this programme now so that real progress can be made in the next 2-3 years
- Continue to champion the proactive release of government information and look forward to seeing current OIA compliance move toward proactive release becoming the norm; you will work with your Ministerial colleagues to support this ambition
- Expect this work to move at pace, utilising the tools available via the Public Service Act
- Indicated an interest in initiatives that will encourage and enable citizen voice in decision-making
- Consider that strengthening the capacity of public service in public engagement, building on the work
 of the Policy Project (NAP3, Commitment 5) and recommendations from the Royal Commission of
 Inquiry into the terrorist attack on Christchurch masjidain on 15 March 2019, is a priority piece of work
 over the next couple of years
- Want to see that work being undertaken with agencies, civil society and the public working together to achieve outcomes that make a difference for people across New Zealand

Dame (Honorary) Suzanne Snively was named in the 2021 New Years Honours as an Honorary Dame Companion for her services to governance. In late 2020, Suzanne completed her final term as Chair of Transparency International New Zealand. Suzanne was a joint Co-Director of the comprehensive Integrity Plus 2013 New Zealand National Integrity System Assessment. She is the author of the TINZ Financial Integrity System Assessment Methodology that provides an opportunity for accounting, legal, audit, risk management and strategic development knowledge to demonstrate the strengths, and advise on ways to enhance the integrity, of New Zealand's financial system.

In her professional career, Suzanne was a Partner at PricewaterhouseCoopers, specialising as an economic strategist. She has been a company director for over 30 years, with extensive governance experience across public, private and not-for-

profit sectors. Suzanne is currently on the Ministry of Transport Audit and Risk Committee, is a Director of New Zealand Opera, Deputy Leader of the Turnbull Endowment Trust, Chief Judge for the Kapiti/Horowhenua Business Excellence Awards, is a member of the advisory board for the Brian Picot Chair in Ethical Leadership, a Trustee of the Opera Foundation and Wellington Theatre Awards. She chaired the Phase 1 Review of the Reserve Bank Act 1989 and is the Chair of Phase 2.

Dr Farib Sos has had wide experience in both the private and public sectors in New Zealand, spanning some 35 years.
